I agree to purchase from Feasible Fuels Ltd my entire petroleum requirements at the specified address from here forth and continuing until such time as one of the parties shall give to the other a prior written notice of termination of not less than thirty (30) days.

I shall give a written notice to Feasible Fuels Ltd of my intent to vacate the premises.

Feasible Fuels Ltd will not be responsible for any damage resulting from any inadequate reserve level of petroleum products if the delivery address remains unoccupied by an individual for more than 48 hours, or if, for any reason whatsoever, oil consumption is unusually high or if, for any reason beyond Feasible Fuels Ltd's control, Feasible Fuels Ltd is prevented or delayed in making its petroleum deliveries.

Feasible Fuels Ltd will maintain a sufficient petroleum supply in the customer's tank if automatic deliveries have been initiated. I agree to advise Feasible Fuels Ltd should the oil level in the tank(s) drop below normal and shall inform Feasible Fuels Ltd in writing of any modification affecting the storage capacity of the tank(s) or changes to the property's heating needs and equipment, so that deliveries can be planned accordingly.

I agree to pay for each petroleum delivery at the posted price in force at the time and place of delivery as governed by Island Regulatory and Appeals Commission (IRAC).

Purchases are due and payable within 30 days of the monthly statement date unless on Budget Plan. A credit cost of 2% per month (26.82% per annum) shall apply to any past due balance. Such credit cost may be modified from time to time by Feasible Fuels Ltd upon notice. I will be responsible to pay any additional charges incurred should the account be passed to a third-party collection agency.

I hereby request credit from Feasible Fuels Ltd I acknowledge and consent to a credit check to apply for credit requested from Feasible Fuels Ltd and to the disclosure of any credit or personal information in the possession of Feasible Fuels Ltd to any credit grantor or consumer reporting agency with whom Feasible Fuels Ltd may transact.

The minimum delivery to which credit can be extended is 300 litres. Deliveries less than 300 litres must be prepaid.
